#### Fundraising Report

Tshirts: \$1500 allocated. Difference is \$223.51 Suggest adding approximately 20 new tshirts. Motion: Allocate an additional \$500 for cost of t-shirts, to allow for additional tshirts for late school. 1<sup>st</sup>: Krista. 2<sup>nd</sup>: Sarah. All in favour. Passed.

Meet the teacher: activities parents want to see – everyone want everything. STEM activities most popular with parents. Movies for students. Most popular fundraiser was popcorn, overall. Jingle Jangle 2<sup>nd</sup> popular. McDonald's night most popular with students.

McDonald's night: one at Standherd has provided a donation to school based on numbers provided. Last year raised \$1500. October 2<sup>nd</sup>/3<sup>rd</sup> or 2 weeks later. Will call McDonald's to see if it could work.

Halloween Dance: was very popular last year. 66% were in favour of having, 72% of kids in favour. Gym is reserved is October 26<sup>th</sup>. **Motion:** Allocate \$750 for Halloween Dance. 1<sup>st</sup>: Debbie. 2<sup>nd</sup>: Krista. All in favour. Passed. Reminder to all that we need lots of hands on deck for events.

Little Caesars Pizza Kits: last year raised close to 800\$. Sarah will look into gift wrapping. Purdy's is an idea. Neiroz to provide additional information regarding gift. Button Artists. That put children's art onto things. Pictures with Santa.
