We were asked to note that for all future events only water and popcorn would be allowed in the gym.

## Food Program Update

It was noted that the food program (i.e. Hot Dogs and pizza) is our most successful fund raising program each year. Last year at this point we had raised over $\$ 12 \mathrm{~K}$ through the food program and this year we have raised over \$17K through the food program.

Jewel noted that Kernals orders would start soon and asked for volunteers to help.

2. A note was made to think about looking into having M\&M Meats provide the BBQ for this years spring fling.

## New and Continuing Business

1. Dale and Mrs. Burans to meet regarding what food and drinks we can have in
the gym and report back to Council at our next meeting.
2. Two fund raising ideas were put forward A) Epicure and B) Coffee. Both were approved by Council. A brief description of each
follows;
A) Kathryn Manley presented an idea for an Epicure fundraiser. The fundraiser is to sell canvas bags containing three jars of spice mix and a recipe booklet containing ideas for using the spices. The bags would be sold for $\$ 20$ each and the school would make a profit of $\$ 8$ each ( $\$ 5$ which is the regular profit plus the $\$ 3$ normally made by the Epicure representative which will be donated back to the school as the rep is a Jockvale grandmother). The parent council voted to go forward with the idea and order forms will be placed in the mail bags on November 12th, with a display to be put up during parent-teacher interviews to remind parents of the fundraiser. Further details were to be worked out between Kathryn and the fundraising chair.
B) Jennifer Jargenson presented and idea for a coffee fund raiser. Her sister-in-law roasts coffee beans and will sell Council 1 pound prepackaged bags of coffee beans for $\$ 11.75$ each, which we in turn would sell for $\$ 20$. Jennifer noted that she was willing to take on the administration of this fundraiser.
3. The teacher representative (Mr. Holden) was asked for his comments regarding teacher participation in extracurricular activities. The following is a copy of Mr. Holden's e-mailed comments to the secretary;
"As many of you know, Bill 157 had many changes to how teachers are treated by the Ministry of Education and the Provincial Government. In light of this legislation many teacher have chosen to volunteer less of their personal time to clubs and sports in order to find balance in our own lives. Many teachers at Jockvale have chosen not to take on extra-curricular clubs and sports for the time being. This is not a form of job action, but a personal choice made by each teacher. The teachers at Jockvale continue to appreciate the support of parents and we hope that the parents will understand our current situation."
4. Dale is to meet with Mr. Sokalski regarding intramurals for the grade 3, 4, and 5s, after which Council will start communication with parents.
5. Dru Mennie noted that Dale Johnson had not actually been elected to the position of Chair during the September elections.
Following which Cindy motioned that Dale be nominated for Parent Council Chair for the school year 2012/13. The motion was seconded by Jewel Lau and was passed.
