Principal's Report

- i. District Reviews being completed by School Board over last few years. JES to be reviewed on December 19th for a full day. Look for connection to school learning plan with what is happening in the classroom, will be speaking with the teachers, students and will be in the classrooms on Dec 19th. Connects with EQAO scoring. School has approximately \$5,000 to spend towards math education for educators. Connie will prepare a post report on the District Review. School learning plan reviews gaps in the school. Numeracy is a big issue at our school as well as across the board. Eight JES teachers met to come up with a plan to address this gap.
- ii. EQAO scores Math Average Board 62%, Average JES 35%, scoring at grade level (3) or above. Our schools include BIP, ILP plan students which typically score lower. JES has a BIP program which most schools do not. Concerns are around application of math from word problems, knowledge and thinking ie. Open-ended problems were a challenge. Focusing on the resiliency of our children, how to incorporate strategies for children to not give up and draw on knowledge. Classrooms are to work in smaller guided groups to allow different learning levels.

Treasurer's Report

- i. October fundraisers brought in \$1,792 less expenses (\$500 float \$715 expenses). September we had to pay out on expenses from commitments for this year as well as commitments from last year. Bank balance \$3500. Less money came from United Way donations this year than in past years. We have applied for HST exemption. Follow ups with Grill Master and Lunch Lady for funds owing are ongoing.
